






Ranking Order by Condition 100 Point Scale

- Building Systems










Ranking Order by Educational Adequacy 30 Point Scale



- New Career & Technical Center Centrally Located
 - Preferred by Business Partnerships
 - All High Schools will have Career courses and Pathways to New CTE Center
 - CTE Center will not 'compete' with High Schools, provides CTE program pathways
- Performing Arts/Dual Language 6-12 Academy at Clay IA
 - Requires Addition
 - CTE Programs Aligning w/ Fine Arts Programs
- Clay HS site becomes much needed athletic practice and competition complex
- Washington HS- Academy for Medical Sciences and Medical Application
 - Operational Medical & Dental Clinics
 - Focus on Sports Medicine (CTE pairing of Sports Marketing etc..)
- Riley HS Project Lead the Way focus
 - Direct CTE feeder into Career School
- Increase HS Utilization from 66% to 75%
- Decreases excess capacity by 840 Seats

 - Addition will be required
- Edison MS will be receiving school for Clay IA Program
- LaSalle and Kennedy Academy would be housed at current LaSalle facility
 - Kennedy building converted to district-wide Pre-K facility
- Increases MS utilization from 66% to 74%
- Decreases middle school capacity by 670 seats

 - Demolition and New Construction on Site
 - All High Schools will have Career courses and Pathways to New CTE Center
 - CTE Center will not 'compete' with High Schools, will provide CTE program pathways
- Washington HS- Academy for Medical Sciences and Medical Application
 - Same as HS Option A
- Riley HS Project Lead the Way focus
 - Same as HS Option A
- Increase HS Utilization from 66% to 72%
- Decreases excess capacity by 630 Seats

 - Would remain Fine Arts Focus High School
- Riley HS Converts to Grades 6-12
 - Consolidates Jackson MS into Riley HS
 - Continues Project Lead the Way focus
- Washington HS- Academy for Medical Sciences and Medical Application
 - Same as Option A & B
- Increase HS Utilization from 66% to 77%
- Decreases excess capacity by 750 Seats

- Jackson MS will be close as a Middle School
 - Move into Riley 6-12
 - Potential Re-use in elementary school master planning
- Increases MS utilization from 66% to 77%
- Decreases middle school capacity by 1,080 seats
